ENVIRO 1A FILTER CART OPERATING INSTRUCTIONS

Before getting into the operation of the filter cart, certain descriptive terms need to be defined to ease the understanding of the instructions. They are:

SUCTION HOSE:

The suction hose draws fuel into the filter cart. It is attached to the smaller of the two filter housings (suction filter).

SUCTION FILTER:

The suction filter is the smaller of the two filter housing. It is equipped with two 100-mesh filter elements. Its function is to filter out large contaminants and to protect the pump from being damaged.

VACUUM GAUGE:

The vacuum gauge is located on the 90 degree elbow at the discharge side of the filter housing. It will tell the operator when to clean or replace the two 100 mesh filter elements in the suction filter housing.

RETURN HOSE:

The return hose discharges the clean fuel out of the filter cart. It is attached to the larger of the two filter housings (outlet filter).

OUTLET FILTER:

The outlet filter is the larger of the two filter housings. It contains two filter elements that do the final filtering of the fuel.

PRESSURE GAUGE:

The pressure gauge is located on the return filter housing. It will tell the operator when to replace the two filter elements.

RELIEF VALVE:

The relief valve is a safety feature on the filter cart. Its function is to divert fuel back to the suction filter in case the return filter elements are clogged or the return hose is plugged.

FILTER CART OPERATION

Operation of the **Enviro 1A** filter cart is fairly straightforward. Simply put both the suction and return hoses into the tank and turn the unit on.

To ensure that the fuel is filtered to a good degree of cleanliness, it is recommended that the total volume of fuel in the tank be exchanged (filtered) approximately two times. This will ensure that nearly all of the particles in the fuel, 5 microns or larger, have been removed.

The filter cart is equipped with a 6.5 G.P.M. pump/motor combination. Use the example and the formula below to calculate the time needed to clean the fuel in a tank.

Example:

Problem: Cleaning up a 500-gallon tank with a 6.5 G.P.M. filter cart

Solution:

Using the equation:

$$\frac{\text{Amount of Fuel to be Filtered (in Gallons)} \times 2}{\text{Rate of Filter Cart Pump (in G.P.M.)}} = \text{Time Required}$$

Therefore, by putting our values into this equation we find the following:

$$\frac{500 \text{ gallons}}{6.5 \text{ G.P.M.}} \times 2 = 154 \text{ minutes or } 2.57 \text{ hours}$$

Therefore we find that the filter cart should be run for 154 minutes in this situation.

Unless the fuel is severely contaminated and needs additional cleaning (sample to determine cleanliness of fuel.)

To further insure that all the fuel is filtered as equally as possible, it is suggested that the filter cart suction and return hoses be placed at opposite ends of the tank. It would also be advantageous to occasionally change the direction the hose ends are pointing.

After the filtering process has been completed, remove the suction hose from the tank while the filter cart is still running. This will force out most of the remaining fuel in the filter housings.

Caution! This process involves running the pump dry. Do not allow the pump to run dry for more than one minute. The fuel being pumped helps to lubricate and cool the gear pump. Damage to the pump may occur if it is allowed to run dry for more than one minute.

Drain cocks are provided at the bottom of both filter housings to drain any remaining fuel.

FILTER ELEMENT REPLACEMENT

Suction and return filter elements should be serviced when the vacuum or pressure gauges go into the red zones. The suction filter 100 mesh elements can be cleaned and reinstalled. The return line filter elements can not be cleaned and must be replaced. Reference the front cover of this booklet for the part number of the elements to be replaced.

It should be noted that the Enviro 1A Filter Cart is equipped with a 40 P.S.I. relief valve. Its function is to divert fuel back to the suction filter in case the outlet filter's elements have been clogged and need replacement. This also ensures that dirty, unfiltered fuel is never discharged out of the filter cart. It also serves as a safety feature to prevent hoses from blowing off if the return hose is kinked or plugged.

WARRANTY CLAIM PROCEDURE

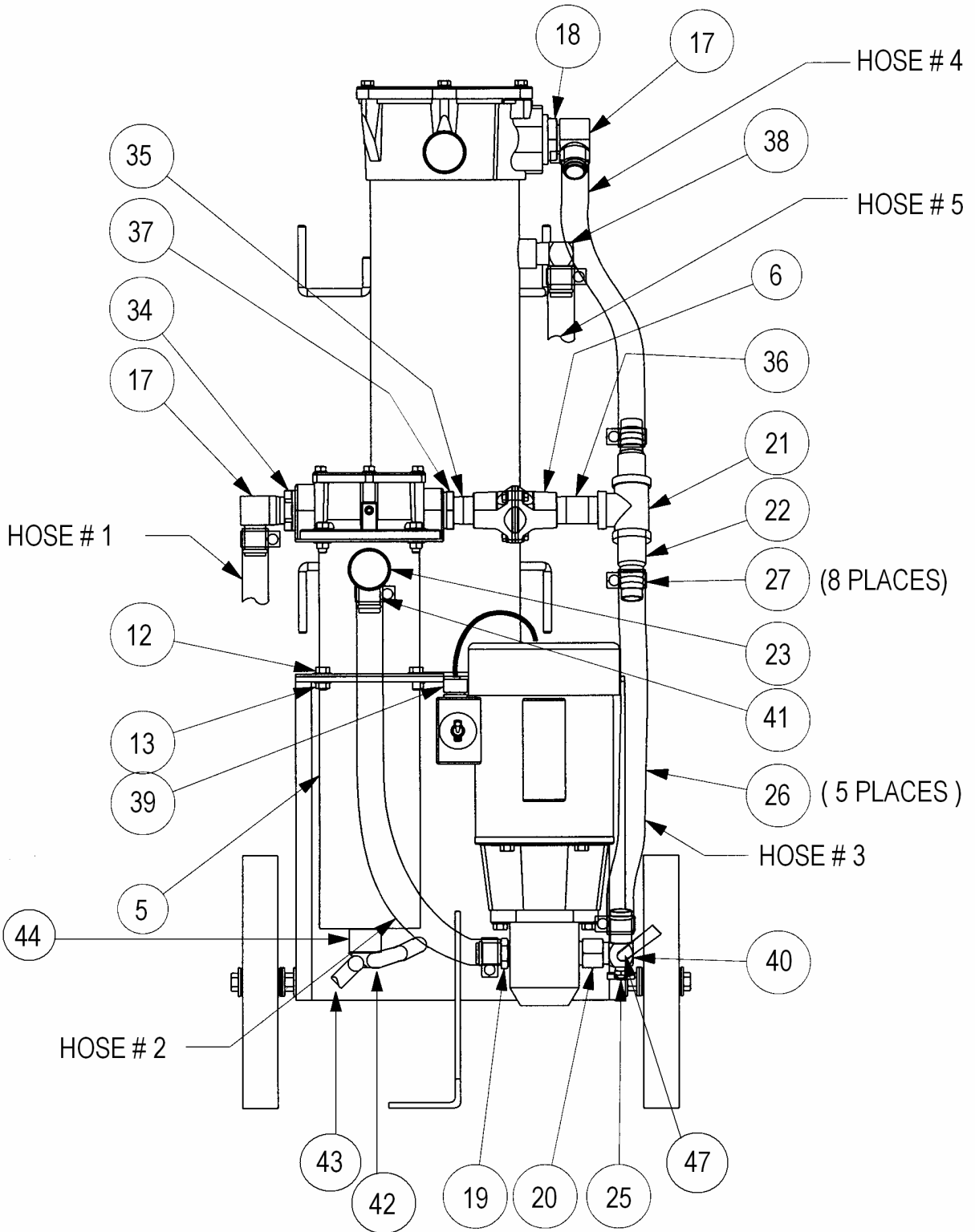
